#### Agenda No 3:

## To propose the Autonomy Budget for 2023-2024

Dr Archana Patki, the IC Principal presented a proposed budget of Rs. 17,89,000/- for the year 2023-2024. This will be sent to the UGC Office, College Development Bureau, New Delhi after the members approval. Details of the budget are as given below:

- An amount up to 2 lakhs will be required for arranging the BoS, Academic Council and Governing Body meetings.
- In consideration with implementation of Autonomy as well as in view of the guidelines of National Education Policy 2020, more funds will be required for Redesigning courses, Training of teachers and arranging Seminars and Conferences.
- For Examination conduction we have proposed fund for IT Facilities and conduction of examination in hybrid mode.
- Under Upgradation of college facilities similar budget is year marked for website management, continuing institutional platforms for online mode of lecture conduction

and staff meetings.

Thus the total budget was discussed at length and an amount of Rs. 17, 89,000/- was approved by the members unanimously.


# To approve the fees schedule for 2023-2024
