- Dr Patki informed that the committee has been re-structured according to the Gazette of India CG-DL-E-05042023-244940 dated April 3, 2023 UGC Notification for approving the budget of government funds.
- With reference to the suggestion made by Shree Pravinbhai Shah, Chairman of SMES regarding a flat annual increase of a certain percentage in fees, Dr.

Bharat Pathak clarified that the guidelines prescribed by the government authorities will also need to be looked into while revising the fees.

- CA Rajpura Sir said that a round figure in fees would make it easier to maintain records.
- Dr Patki requested for clarification regarding the field visit fees which are being charged for students. It helps our students to pay the balance amount if any at the time of the visit instead of the entire amount to be collected just prior to the visit. She requested for the same practice to continue. Dr Bharat Pathak suggested that enquiries be made in other colleges too and that we may decide in the best interest of our students.
