COLLEGE WITH POTENTIAL FOR EXCELLENCE AN HONOUR AND A CHALLENGE!

The College has received the University Grants Commission (UGC) Grant for College with Potential for Excellence (CPE). The UGC honour signifies the capacity of the college to achieve targets the college has set for its development as a centre for excellence in education. It is a natural progression after receiving a high 'A' Grade in the NAAC Accreditation (2nd cycle) and also the fulfilment of a proposition given by the NAAC Peer team which visited the College in the month of August 2013.

The selection of the College was through an exhausting process set by the UGC. The proposal prepared by the IQAC, in the first stage underwent comprehensive scrutiny by a panel of high ranking officials of the SNDTGU. The college was placed 2nd out of 6 SNDTGU affiliated colleges that had applied under the same scheme. The proposal was then forwarded to the UGC which invited the Principal for an Interface meeting. We are among the 8 colleges from Mumbai to be awarded this honour and of the 2 select-

ed from SNDTGU. The Grant places immense responsibility on the Management, the Principal, the faculty members and the non-teaching staff. With focus on student and faculty development, the highlights of the proposal are as outlined:

- setting up of smart classrooms to enhance the teaching-learning experience; more incentives for teachers to participate in research related activities and importantly incentives for students to motivate them for research.
- setting up of a Social Inclusion Cell that can plan and execute urban and rural outreach programmes; nutritional support scheme for students representing the College in Sports, NCC, NSS and Students' Council activities and taking concrete steps in order to create a green campus.
- four aided departments which have been identified as the best performing departments:

- Psychology, Sociology, Hindi and Economics; need to gear up to undertake tasks under the CPE.

- similarly other departments and the various committees need to take on additional challenges to fulfil targets.


The College awaits the Grant which may be upto a maximum of INR 1.5 crores, to be utilized from 2016 to 2021. During this period the College will be sending regular progress reports to the UGC for which the documentation will be of paramount significance.

The role of the IQAC will be that of a guiding and monitoring body which will lay down the objectives, delegate responsibility and help in the implementation of the set plan. The CPE gives the College varied opportunities and in accomplishing them it establishes the College as a noteworthy institution in the field of higher education.

RESEARCH, CONSULTANCY AND EXTENSION

The Research Consultancy and Extension Cell of our college was founded on this very ideal. Studies show that students who engage in research are twice as likely to graduate and have more successful careers after graduation. The Cell promotes a research bent of mind among the faculty and students by steadfastly encouraging them to take up research based activities. The Cell conducts several programmes to support the staff to enroll for M.Phil and Ph.D programmes, undertake UGC sponsored research projects. The Cell encourages the staff and students to publish their works in leading journals and to present papers at national and international conferences.

Management, knowing the importance of

R&D has been magnanimous to sanction necessary funds for Research and Development. Apart from this, under the 'College with potential for Excellence' (CPE) funding will be done for upgrading research cell via planned activities as under:

- Incentives to teachers such as: Teacher Assistance, Increased seed money for publication, assistance for subscribing to various international and national journals etc.
- Both PG and UG level students will be provided grant like membership funds and printing funds and will be skilled to opt for doctoral studies.
- Also funding is planned for upgrading the in-house Research Journal ('Concept' ISSN Journal) with better

quality of publishing and design to attract reputed scholars and researchers to contribute to the research journal.

- It is also planned to set up Social Inclusion Cell as a part of extension activity and take up 4 Urban and 1 Rural outreach program. For this travel grant is planned to be availed to the students involved in extension activity.

CPE funding will support Research Consultancy and Extension cell of the college to improvise the research culture among students and faculty and increase the academic research output.

Keeping Framework**


Under the CPE, in order to facilitate record keeping, a policy aimed towards providing an overarching framework for information management policies, and procedures needs to be framed for bettering the documentation process.

Records form the corporate memory of an Institution and as such are a vital asset that support ongoing operations and provide valuable evidence activities over time. Recordkeeping practices, processes and systems assist in making full and accurate records.

With the Institution receiving the CPE, it becomes imperative that an Administrative Record Keeping

Framework is designed that are relevant and implementable to ensure that documents are preserved and maintained over time for as long as required to meet administrative, legal, fiscal and archival requirements.

The framework should enable easy access to information, with the help of seven essential recordkeeping activities :

INNOVATIONS AND BEST PRACTICES

**For the Well Being of
Student Community**

As more than one thousand five hundred teenage students occupy our college every day for more than four hours, minor accidents, health complaints and unfortunate health complications become matters of concern. For the health benefits of students we need to have an easily accessible First Aid Centre or Health Centre on campus.

The IQAC rightly understood the significance of this facility and listed its construction as one of the prime requirements in its CPE proposal. This facility, meant for treating an ailing student, does not require sophisticated medical

equipment or the presence of a medical doctor continuously. And, hence, it will not be expensive for the college to set it up.

The Health Centre/First Aid Centre will have basic medicines that are available over the counter (for example, pain killers, decongestants used to treat cold, drugs to treat diarrhea, glucose powder and so on), lotions to apply on wounds, cotton and bandage. A couple of beds are a must along with some tools like thermometer and blood pressure machine and, most important of all, a trained paramedic in charge of the centre.

These basic facilities will provide timely medicines, treatment and a bed to lie down to students who

often suffer from fatigue, dizziness or other complications related to women's health.

As our campus offers degree courses in nursing the assistance of the SMES College of Nursing would be sought to set up and run this facility. Is it a lot to ask for, for the sake of our hardworking students who burn midnight oil during exams, run around for hours during cultural programmes and devotedly play in hot and humid conditions to bring laurels to college in sports events? After all, we are in charge of future PV Sindhus and Sakshi Maliks.
